 2. Portland State University students offer youtube videos marketing the importance of health insurance.
 3. Last year an OSU Public Health class discussed CoverBeavers and the Affordable Care Act.

 1. Matt Bayer suggested OSU Smoking Ban and Social Media. Ashleigh Anderson discussed the OSU first year communication plan with autogenerated messaging.
 2. Jenny Haubenreiser suggested a subgroup in SHAB to make a list of plans. Ryan asked if anyone is specially interest in marketing. Gaby and business majors will have many ideas. Lyndi mentioned that ASOSU has a huge marketing budget and excellent marketing team with graphic designers and promotion outreach coordinator. Jenny will meet with Lyndi and Gaby.
